Reseller Net Sales	Premium Rate/Payment
Tier 1 (\$0 - \$2,000,000)	\$1.15 per \$1,000 of invoiced seed
Tier 2 (>\$2,000,000)	\$1.10 per \$1,000 of invoiced seed

*\*Year-end sales includes seed shipped direct to growers and/or locations other than the primary location*

- Accounts must be settled by July 15, 2018

### Policy Term

- August 1, 2017 to August 1, 2018 renewed annually thereafter unless cancelled
